THIS INCLUDES THE ADDITION OF 2 NEW SHELTERS - ONE IN BROOKLYN AND ONE IN MANHATTAN. WIN SHELTERS PROVIDE VOCATIONAL, EDUCATIONAL, JOB TRAINING, AND PERMANENT HOUSING ASSISTANCE. WIN HOUSING ADDRESSES PHYSICAL AND MENTAL HEALTH ISSUES, SUCH AS SUBSTANCE ABUSE, LEGAL ISSUES, DOMESTIC VIOLENCE, ENTITLEMENT BENEFITS AND SOCIALIZATION NEEDS. IN FY 2015, OUR TRANSITIONAL RESIDENCES FOR HOMELESS FAMILIES SHELTERED FIVE TIMES AS MANY FAMILIES AS TEN YEARS AGO.

WIN WAS ONE OF THE FIRST TO PROVIDE ON-SITE CHILD CARE; WITHOUT THIS SERVICE MANY OF OUR CLIENTS WOULD NOT BE ABLE TO ATTEND. SERVICES INCLUDED INDIVIDUAL COUNSELING, MEDICAL ASSESSMENTS, RELAPSE PREVENTION, DRUG AND ALCOHOL EDUCATION, PARENTING AND ANGER MANGEMENT GROUPS. WE RECENTLY ADDED THREE SATELLITE CLINIC REFERRAL CENTERS THAT ENABLE US TO SCREEN AND REFER CLIENTS IN FOUR WIN SHELTERS FOR SUBSTANCE ABUSE TREATMENT SERVICES.
